

The Jiu Jitsupedia LLC Parental Consent Form

PLEASE PRINT THIS FORM AND GIVE TO YOUR PARENT/ LEGAL GUARDIAN

Dear Parent/Legal Guardian:

This letter is to inform you that your child has recently visited the [jiujitsupedia.com](http://www.jiujitsupedia.com) Web site (the “Web Site”). In order for someone to navigate through the Web Site, they must register, a process that requires them to give personally identifiable information, such as name, address, telephone number, date of birth, e-mail address, etc. (“Personal Information”). We are prohibited by law from obtaining Personal Information of a child under the age of thirteen (13), without the advance, signed, written consent of the child’s parent or guardian. Your child is now requesting your permission to fully participate in the Web Site.

In case you were not with your child when he or she attempted to register, we encourage you to visit our Web Site at <http://www.jiujitsupedia.com> to see for yourself what is offered at the site and to determine whether you will consent to allowing your child to register at the Web Site. The protection of children is very important to us, as is the privacy of our members. With your approval, we will activate your child’s account so that your child can enjoy all aspects of the Web Site.
